
On March 7, 2007 I filed a written complaint with the Illinois Attorney Registration & Disciplinary Commission (herein "IARDC") and on approximately June 11, 2007 or shortly thereafter I received a response to my complaint against David J. Wessel from Dorothy B. Zimbrakos. Of course she, nor the IARDC did not thoroughly investigate my complaint, because if it had been, then she and the IARDC would have realized that there was no disturbance and Judge Donegan (now deceased) did not request that I leave. The sheriff deputies inside and outside the courtroom on that day all lied under oath and committed perjury at my trial. I spent 30 days in jail because of David Wessel, Eric Gross and the rest of these so called officers of the law. I had an interview with the Cook County Sheriff Department's Internal Affairs Division after I filed a complaint against the officers involved and the first thing that they said was, "We are not going to fire anybody." I could not believe this. I have enclosed a copy of the transcripts of the above captioned court proceedings on the date of 2/2/07, along with an audio tape of the same proceeding to prove what I am saying is true. Those officers and other officials whom Ms. Zimbrakos and the IARDC claimed they contacted and interviewed, they all lied to your faces. If you actually take the time to read the transcript and listen to the audio tape, you will clearly see that there was no disturbance whatsoever from me or anyone who was near me in the courtroom. I have also enclosed a copy of documents which Sheila Mannix filed in a RICO lawsuit, which is currently in federal court. Read the packet and hopefully you will have an inkling of why this happened to me. It is your job to do the right thing. I am sending this information to you and hope that you proceed accordingly. It's as if those who are trying to do the right thing get punished and those who are corrupt get a pat on the back or in one of the sheriff deputies named Morrissey's case, he got promoted to sergeant. Job well done. Corruption will never come to an end as long as there are all of these phony organizations and agencies who are getting bought by funding

from the government, if they actually do what they are supposed to do, their jobs would be done and that would be the end of their money. If it is your job to discipline, then please discipline or give the job to a person who will do the right thing. I have had my Constitutional and Civil Rights violated, by the lies of this person who calls himself an attorney, David Wessel. If you need further information, please let me know. I am sending you this in good faith and am looking forward to a response. I have also sent a copy of your original response along with a copy of my original request for an investigation into David Wessel.
