MOTION FOR LEAVE TO FILE AMENDED COMPLAINT

NOW COMES, the Plaintiff, Jaime Hernandez, unrepresented and indigent, respectfully requests that the court grant him leave to file an amended complaint and support whereof Plaintiff asserts and explains as follows;

On 12/16/09's Docket Entry (see Attachment A) which says, "The Court will entertain a motion to file an amended complaint if and when Plaintiff tenders a proposed amended complaint to the court for consideration."

Plaintiff's original complaint when filed lacked substantial information which is critical to the above captioned case. Plaintiff is not an attorney and has realized that his original complaint was deficient in several places. Plaintiffs original complaint needed to be amended to add additional defendants who were involved in failing to thoroughly investigate the officers in Plaintiffs complaint against the named Defendants (Cook County Sheriff Department Officers); Plaintiffs amended complaint needed to be

amended to add additional defendants who were involved in conspiring against Plaintiff, forcing Plaintiff to be subjected to a sham trial and wrongful incarceration of Plaintiff in Cook County Circuit Court, located at 555 W.
